What was considered?

- Bulb-outs ("chokers")
- Crosswalk/raised crosswalk
- Electronic Speed/Radar signs
- Flashing pedestrian crossing light
- GPS Re-routing (WAZE)
- Increase Cary Police presence/enforcement
- Median and paving modifications

What was considered?

- Radar speed signs
- School bus stop signs
- Speed humps
- Speed limit signs
- Stop signs
- Street marking, painting, texturing
- Transverse rumble stripes
- Traffic circle

Evaluation Criteria

Has the traffic calming device been shown to:

- reduce speed?
- reduce traffic volume?
- increase pedestrian safety?
- increase vehicular safety?

Evaluation Criteria

- Would it be an inconvenience for residents? *
- How would it affect vehicle operation?
- What are the associated costs for the HOA/residents?
- Would it be a temporary installation, or permanent?

Each member of the committee assigned a score for each device for each factor. The ideas that got the lowest scores were dropped from further consideration.

Why 31 Flavors?







What's it gonna cost me?



What's it gonna cost me?

Short Answer: Zero

The Town is covering 75% of the cost.

The HOA has indicated its willingness to cover the remaining 25%.

What's next?

The committee will:

- Review what we have discussed tonight.
- Consider modifications the traffic calming plan.
- Circulate a petition/ballot for resident approval of the plan.

Approval Process Requires 70%

- The HOA will distribute the petition/ballot.
- Owners return ballots to the HOA.
- Volunteers gather additional ballots.
- We have six months to reach the 70%.

Results

If 70% yes, construction begins.

 If fewer than 70% vote yes, things remain the same or get worse.
